TERMS AND CONDITIONS OF THE Bitcoin Pizza Day CONTEST

§ 1. Preliminary provisions

- The Organizer of the Bitcoin Pizza Day contest hereinafter referred to as the "Contest" is COINDEAL LIMITED with its registered office in Republic of Malta, Villa Malitah, Mediterranean Street, The Village, St. Julians STJ 1870; registered under number C 88465, income tax number 999456434, VAT number: MT 2563-7720, hereinafter referred to as the "Organizer".
- 2. The funder of the prize is the Organizer.
- 3. The Contest will start on the May 22, 2020 at 8:00 a.m. (GMT+1) and will last until the May 22, 2020 at 23:00 p.m. (GMT+1).

§2. Rules for participation in the contest

- 1. The Contest is intended for all those interested who, until its completion, meet the requirements set by the Organizer, hereinafter referred to as the "Participant".
- 2. To take part in the Contest, each Participant has to, during Contest:
 - a) be a User which is validly registered on the Organizer's Platform,
 - b) have valid and operational account,
 - c) have verified account on Starter level,
 - d) not be a citizen or resident of the sanctioned countries mentioned on the bottom of the page available on the website: https://coindeal.com/legal/aml-and-kyc,
 - e) make at least one trade on the Organizer's exchange (understood as buy or sell transaction) on the day of 22nd May,
 - f) purchase a pizza with a maximum value of 15 USD or equivalent in other currency,
 - g) send Organizer via e-mail:
 - photo presenting pizza and Participant (without any third parties),
 - consent to share image in Organizer's social media and website, e) above,
 - photo of the receipt with clearly visible price of the pizza mentioned in the first indent above,
 - information in which currency the reimbursement should be done.
- 3. Documents and information mentioned in the letter g) above should be sent in one e-mail to a specially created e-mail: bitcoinpizzaday@coindeal.com.
- 4. The winners will be determined by the order of sent e-mails. The first 100 Participants who sent e-mail that meets all criteria will win.
- 5. Each Participant in entitled to submit only one pizza for the reimbursement. In the situation, there are two or more pizzas on one receipt, the Organizer will reimburse the price of the cheapest one considering it as a one bought by the Participant even in the situation when their sum of prices is lover that 15 USD.
- 6. Each Participant is entitled to send only one e-mail mentioned on the point 3. above. In the situation, when Participant will send more than one e-mail, only the earliest sent e-mail will take part in the Contest.
- 7. Failure to meet at least one of the criteria specified in point 2. above may result in disqualification from the Contest.

§3. Prize

- 1. Organizer will reimburse the price of the pizza purchased by the Participant.
- 2. Participant will be entitled to choose the currency in which Organizer will reimburse the price of the pizza. Available currencies are: CoinDeal Token (CDL) or Bitcoin

(BTC). Information about currency chosen by the Participant should be provided in the e-mail mentioned in the §2 point 3.

- 3. Organizer will reimburse:
 - a) full price of the pizza, if Participant chooses reimbursement in BTC, or
 - b) one and a half of full price of the pizza, if Participant chooses reimbursement in CDL.
- 4. Results of the Contest will be announced on Organizer's social media and on Organizer's website's news section on the May 25, 2020 at 15:00 p.m. (GMT+1). There will be announced the list of 100 winners and published photos send by them.
- 5. Chosen currency will be deposited on the Participants wallet on the Platform within one week after the results announcement.
- 6. The Prize cannot be exchanged for cash or any other type of Prize.
- 7. If other than USD currency is used to purchase the pizza, the Organizer shall convert the prize at the current rate of exchange published on the Organizer's Platform.

§ 4. Final provisions

- 1. Participation in the Contest is unequivocal with the agreement to this Terms and Conditions.
- 2. In all matters not regulated in this Terms and Conditions, Maltese law shall be applied.
- 3. The Organizer reserves the right to change the rules during the Contest and undertakes to immediately publish the amended regulations in place of the previously published rules of the Contest.
- 4. In all matters not regulated in the Terms and Conditions, decisions are made by the Organizer with respect to binding provisions of law.
- 5. The Organizer reserves the right to change the date of the Contest, stop it or suspend it for important reasons.
- 6. In the situation any tax obligation arises due to the Organizer's reimbursement of the pizza price, it is the responsibility of the Participant to fulfil it.
- 7. Taking part in the Contest means that the Participant accepts and agrees that the Organizer will process, transfer and secure Participant's personal data in accordance with applicable regulations, including the provisions of the GDPR (art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC <General Data Protect Regulation>) as follows:
 - a) Participant data will be used to transfer the award,
 - b) Participant data will be used to store information about the Contest for internal purposes of the Organizer,
 - c) the Organizer will publish winners' name and image on Organizer's social media and Organizer's website's news section and other internet social and information platforms, to announce the winnings, publish image of the winners and inform about the Contest and its conclusions.
